Proposed Revision to MARTA's Code of Ethics and Standards of Conduct

Under Section 13. Contracts Involving Former Employees – changes include:

Therefore, as a general matter, the Authority shall not enter into any contract with, nor take any official act or action favorable affecting any person or any business represented by or employing such person who within the preceding twelve month a Board member or employed by the Authority in a position that creates a conflict with the employee's subsequent employment. This prohibition shall be reduced to a six-month period for those employees whose employment with the Authority was terminated due to a reduction in force. From time to time the MARTA Ethics Committee will review this section to various positions which the Authority may be considering for third party contracting opportunities and may determine that it would not be a conflict for an entity to employ MARTA employees within the one-year period of the elimination of their positions within the Authority.

Section 16. Compliance with Applicable Laws & MARTA Ethics Committee

MARTA's General Manager and the Chief Counsel shall establish the MARTA Ethics Committee. The Ethics Committee shall be charged with evaluating and administering the MARTA Code and with determining all Code related matters including all conflict of interest, matters arising from the current and post-employment status of MARTA employees. The Ethics Committee shall be comprised of various MARTA officers and functional leaders including the Chief Counsel, Chief Compliance officer, Head of Human Resources and (......).
