





What is Single Tracking?

Single tracking is when we run trains in both directions on a single track in a particular section of track.






Who Performs Single Tracking?

Single tracking is an industry standard used by many agencies.

- CTA (Chicago)
- Maryland Transit Administration (Baltimore)
- WMATA (Washington DC)
- Sound Transit (Seattle)





When We Implement Single Tracking

- **Weeknights:** After 9:30 PM Low ridership enables critical maintenance and infrastructure upgrades
- Weekends: Flexible Long / Short Windows (Friday 9:30 PM to Monday 04:00 AM)
 Leverages extended low-traffic periods for major projects

Category	Example	Attendance	Ridership	Single Tracking Plan
Holidays & Major Events	Juneteenth, 4 th of July, FIFA, SEC, PRIDE Festival	Varies	Varies	No Single Tracking scheduled the day of the Event.
Large Scale Crowds	Atlanta United, Falcons, Sports Events (March Madness), Concerts (Beyonce, Taylor Swift)	45,000 +	8,000 +	No Single Tracking before, during or until after the Event crowds have cleared, system-wide.
Mid-Level Crowds	MBS Concerts & Events, Ga. Tech,	18,000 - 44,999	1,500 - 7,999	No Single Tracking at stations serving the event venue before, during, or until after the Event crowds have cleared. Single Tracking permitted at other locations.
Small Crowds	State Farm Concerts & Events, Festivals, GCWW Events, Hawks, Ga Tech, Piedmont Park Events	0 to 17,999	Below 1,500	Single Tracking can commence.
Special Considerations	Road Closures, Multiple Events	Varies	Varies	Single Tracking may be halted or cancelled.




Why We Single Track

Single tracking ensures construction safety and rail service continuity.




