# Resolution Authorizing the Award of a Contract for the **Traction Power Substation Replacement Program Wave 1** IFB B50502





## **PURPOSE**

- Procurement of Electrical Services from a single firm/team to renovate and replace existing traction power equipment at Traction Power Substations (TPSS) and Gap Breaker Stations (GBS) across MARTA's rail lines.
- This work supports the uninterrupted propulsion of MARTA's rail cars and is the first of eleven (11) waves of priority-based locations. Current locations include TPSS at Five Points (two TPSS Sites), Midtown, and Candler Park Stations, and a GBS near the Ashby Tunnel; subsequent locations are currently in the planning stage.
- The MARTA TPSS System consists of, but is not limited to, the below equipment:
  - Medium Voltage AC Switchgear
  - Transformers
  - Rectifiers
  - DC Switchgear





## PROCUREMENT CONSIDERATIONS

- The Invitation for Bid was advertised on 10/04/2024.
- Cleveland Electric Company, submitted the only bid on 01/14/2025, in the amount of \$49,901,545 and was determined to be a responsive but nonresponsible Bidder.
- Negotiations with the Bidder resulted in a \$2.2M savings.
- The Department of Internal Audit conducted a cost/price analysis and determined \$45,363,653.25 of the bid price is fair and reasonable while \$2,378,187.75 required further substantiation that was provided by CPD to the Interim General Manager for his review and approval.

**WHEREAS**, the Authority's Office of Capital Programs Delivery has identified the need for the Procurement of Traction Power Substation Replacement – Wave 1, Invitation for Bids Number B50502; and

WHEREAS, on October 4, 2024, the Metropolitan Atlanta Rapid Transit Authority duly sent Notice of the Invitation for Bids to potential Bidders; and

WHEREAS, notice of the said Invitation for Bids was advertised in the local newspaper of the largest circulation in the Atlanta metropolitan area, once in each of the two weeks prior to opening bids; and

**WHEREAS,** all Bidders were given an opportunity to protest the bid instructions, specifications, and/or procedures; and

WHEREAS, on January 15, 2025, at 2:00 p.m., local time, one (1) bid was publicly opened and read aloud; and

**WHEREAS,** the single bid submitted by Cleveland Electric Company, is responsive but non-responsible because the bid price was over 50% of MARTA's Internal Cost Estimate (ICE).

WHEREAS, the Department of Internal Audit (IA) conducted a cost/price analysis

to determine if the bid price is fair and reasonable. IA determined the amount of

\$45,363,653.25 is reasonable and is supported with sufficient documentation. The

remaining \$2,378,187.75 is unsupported due to insufficient documentation. Capital

Programs provided additional documentation and the Interim General Manager/CEO

concluded based on the review of the solicitation process, audit findings, and subsequent

validation of the questioned costs that the bid contract value of \$47,741,841.00 with

Cleveland Electric Company is justified.

**RESOLVED THEREFORE**, by the Board of Directors of the Metropolitan Atlanta

Rapid Transit Authority that the Interim General Manager/CEO or his delegate be, and

hereby is, authorized to execute a Contract on substantially the same terms and conditions

as contained in the Invitation for Bids Number B50502, Traction Power Substation

Replacement – Wave 1, between the Authority and Cleveland Electric Company in the



## **Program History**

- Requested the Board for the use of the RFP procurement process in early 2023 for the Procurement of Construction Services for JOC 3.0
- A construction Management/Procurement Team, Gordian Group, was awarded a JOC 3.0 contract in early 2023
- MARTA and Gordian coordinated and assembled the Construction Vendor procurement documents and advertised and started procurement in early 2025.
- The JOC 3.0 Program received and vetted the request for proposals from six vendors/contractors. Three vendors/contractors were selected for the program






# **Scope of Work**

The JOC Program proposes to repair, renovate, and rehabilitate new, medium-sized construction projects.

- From \$501K up to \$2M construction cost
- Including but not limited to facilities renovations, equipment installation, electrical, mechanical, civil, and communication scopes of work, that are required to maintain the good state of the Authority's assets.
- Each new project will be awarded to one of the multiple construction vendors based on their ability to deliver the scope.
- Only one JOC Contractor will perform construction services on any individual project from the JOC contractor pool.





## Cost

- Total program cost is \$25M
- All project costs will be supplied by the sponsoring department

## **Funding**

FY26 Budget - \$250,000 (Gordian Costs Only)




